During the play, illegal kick, R elects to decline the penalty and take the result of the play

Illegal kick by #4

Illegal kick by your player that will result in the receiving team taking the ball at the out of bounds spot or a replay of the down after penalty enforcement.

Coach your kicker illegally kicked the ball off the ground. That penalty was declined and it's R's ball at the 18


Legal scrimmage kick, muffed by the receiving team. Illegal kick by K. R will take the ball on the 18. First down.

What do you say to the coach of K?

R chooses to accept the penalty for kick catching interence. We will play an untimed down.

KCI on your #23. If they accept, we will go 15-yards from the spot of the foul and we will have an untimed down.

During the play K## did not provide R## unobstructed opportunity to catch the ball. R can accept the penalty and the period will be extended for an untimed down.






