

What do you tell the coach of A?

13 responses

The try is good. Result of the play R## roughed K6 during the kick. Penalty will be asset first play of overtime. Succeeding spot.

Roughing the kicker. You have the option to enforce on the try from the  $1\ 1/2$  or enforce at the start the OT.

You have options, coach. Accept the penalty and replay the down from half the distance. Accept the result of the play, and take the 15 yard penalty in OT.

Roughing the kicker on the defense. Would you like to replay the try or have it assessed in overtime?

Roughing the kicker - want to enforce half distance or enforce in overtime?

penalties don't carry over into overtime

Kick is good; enforce the penalty from the succeeding spot depending on the result of the overtime coin toss.

roughing the kicker. Penalty will be assed on the kickoff.







During the kick K84 bumps R18 prior to the ball arriving.

KCI on K84. Penalty enforcement decisions rest with R.

KCI on #84. Receiving team will have options, please hold on coach.

Kick catch interference on number 84, and first touching by number 84.

KCI on 84

Fair catch interference

KCl by #84. Receiving team will likely accept the result of the play. R 1/10 at the K-40.

Kicking player first touching on player #x

KCI on # \*\*, receiving team has multiple options to start their series.

Coach, there was contact before the ball arrived by #84 . R is going to take the result and have 1st down.

Kick catch interference #29. (insert option from R)

KCI at the R42, first touching @ R42, result of the play R 1/10 K40

kick catch interference (KCI). ES is the R-42. R's ball, 1st and 10 at the K-43.



What do you tell the coach of R?

12 responses

During the kick and prior to the ball arriving. K84 bumped R18. You have these options.

KCI on K84 at the R-42. If you want K to rekick, it will be 4th and 17 from the 5. Otherwise, the most advantageous result for R will be to decline the penalty and take the ball first and 10 at the K-40.

Coach, you have options here. You can accept the result of the play (which will be at K-40) or 15-yard penalty from the spot of foul, or rekick.

Kick catch interference on k, and first touching on k. Would you like to keep the ball, or re-kick?

KCI on K84

Fair catch interference

KCl, kicking team # 84. Your best option is to decline the penalty and accept the result of the play. R 1/10 at the K-40.

KCI on # \*\*, receiving team has multiple options to start their series.

Coach, we had a KCI on K#84. I want to confirm you are going to decline and take the result of the play? Youll have a first down at their 40.

Kick catch interference. Do you want the ball 1st and 10 at the 43 going in or do you want to enforce from the previous spot and replay the down?

KCI at the R42, first touching @ R42, result of the play R 1/10 K40

kick catch interference (KCI) on K. ES is the R-42. R's ball, 1st and 10 at the K-43.



What do you report to the Referee?

13 responses

Result of the play KCI on K84 bumped R18 prior to the ball arriving during the kick.

KCI on K84 at the R-42. R's best options will be either to rekick and enforce the penalty half the distance or decline the penalty and take it first down from the K-40.

During the kick, I have KCI, on K-84 at the R-42. R-42 is also the first touching. R has options, but the result of the run is better than first touching or 15-yard KCI. Or can take half the distance and re-kick.

Result of the play was a punt returned to the plus 40-yard line. During the kick, first touching by k at the minus 40, and kick catch interference at the r-42

There's also the play run to K 40. Catching interference on K 84.

Fair catch interference

End of the run by R at the K-40. End of the kick at the R-42. Prior to the end of the kick, KCI, K84 at the R-42.

Prior to the catch ilegal contact by the kicking team, first touching, receiving team recovered and the ball is dead at the K40.

KCI on #\*\* at R42

KCI on #84 of the K team, penalty is declined. Result of the play is 1 down R . Signal

Result of the play is a return, tackled in bounds. Before the return, KCI #29 of the kicking team. (insert option from R)

KCI at the R42, first touching @ R42, result of the play R 1/10 K40

kick catch interference (KCI) on K at the R-42.
