## What do you tell the coach of A?

Following the interception, BSB by one of your players. They elected to take the penalty on the kickoff.

Illegal blindside block on number ##. Your opponents chose to enforce the penalty on the (try or kickoff)

TD Counts. Penalty occurred during the runback. 15-yard penalty will be enforced on the ensuing kickoff.

Result of the play is a TD. After the change of possession and during the run, illegal blindside block A # XX. B will have the option to enforce the penalty on the try or the kickoff.

The TD will count. Blindside block number 56. The penalty will be enforced on the (insert option from B)

Touchdown by B blindside block by A. B can choose to accept the penalty on the try or kickoff

After the interception, BSB #12 Offense
