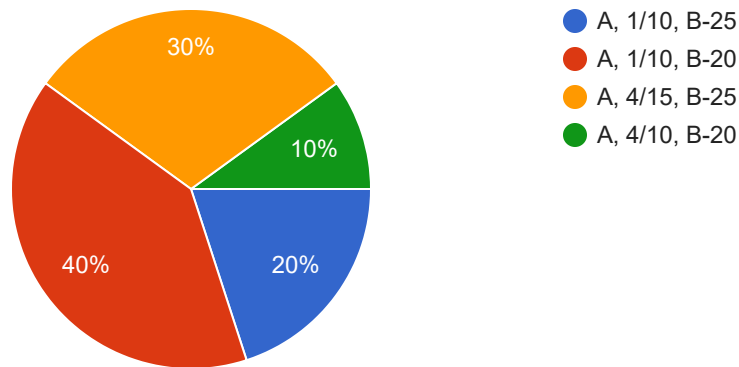

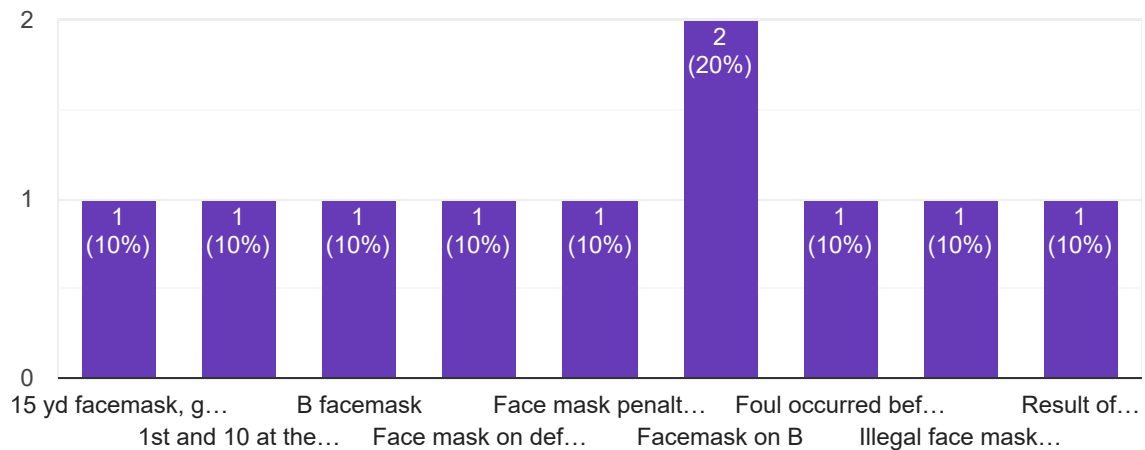

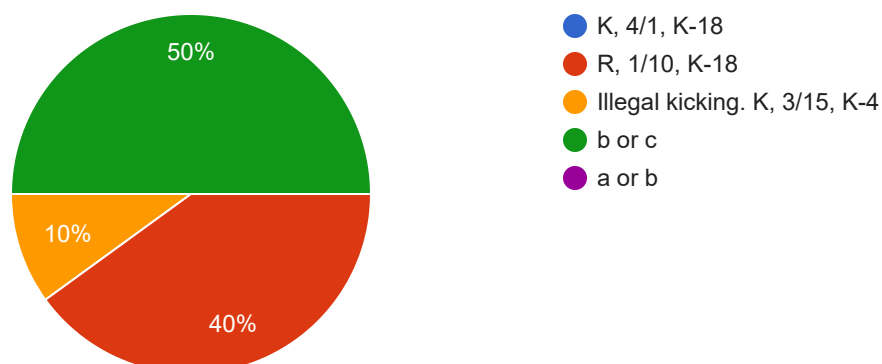

Illegal kick by K at the K-8. 15-yard penalty Will be enforced from the spot of the foul (K-8) and the ball moved back to the K-23 and Loss of down. R's ball, 1st and 10 at the K-23.

Result of the play is a muffed ball out of bounds. Illegal kick #4 on the kicking team.

Muffed kick out of bounds at the 8 last contact of the leg of R

Results- ball out of bounds - Illegal kicking @k8 - enforced 1/2 distance -

Result of the play is a an out-of-bounds scrimmage kick at the K-18. The scrimmage kick crossed the neutral zone, was muffed by R at the K-25 and the ball rolled behind the neutral zone where K XX illegally kicked the ball from the ground.

What do you tell the coach of K?

the kick only went 6 yards, not the mandatory 10 and No Team R player touched the ball. Therefore, Your recovery is illegal (Illegal Touching). Illegal touching (not a foul, but gives Team R the right to take the ball at that spot — K-46). Also, you may not block Team R players during a free kick until they are eligible to touch the ball (after the ball has gone 10 yards.). Your player blocked at the R-49 before the ball had gone 10 yards and before it was touched by Team R, This is a kick-catching interference foul or illegal block during a free kick by Team K. Team R is going to accept the penalty for the illegal block, and it will be their ball 1/10 at the K-46.

Illegal blocking on #87. (tell him whatever option R selected)

Ball did not travel 10 yards

Illegal touching - five yard penalty

First touching by K at the K-46 where K recovered the ball. Illegal block by K XX at the R-49.

Can't initiate contact in the 10 yards

Result of the play is first touching by A## at the K-46.

The ball was recovered by your team before it went 10 yards. It will be first down for the return team from the spot of recovery

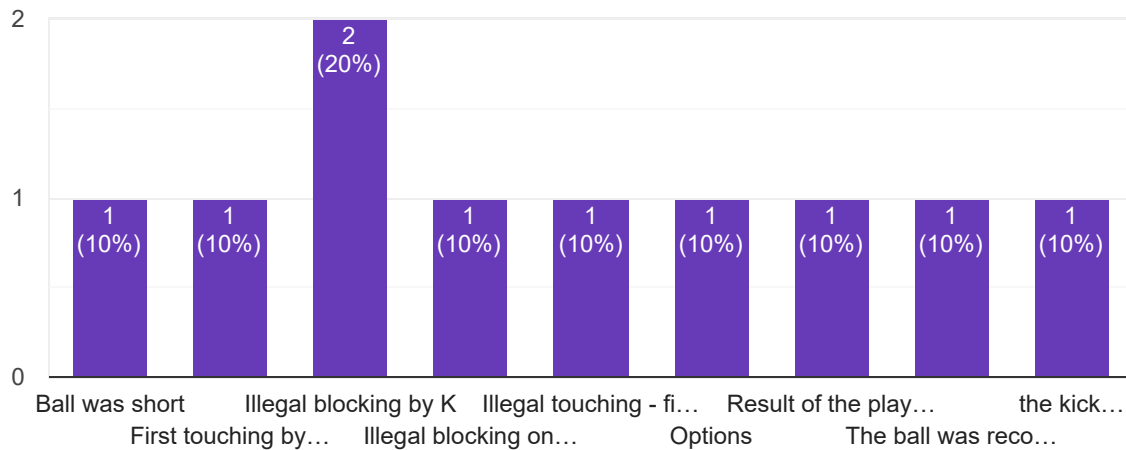
